Fire Investigation and Follow Up

Other

- Put fire prevention material together for this month's visits to our local schools and for our upcoming fire prevention week open house at Station 1.
- Review my disposition and appear in Circuit Court in Grand Haven as ordered by my subpoena for the scheduled trial between Patti Rands and Georgetown Township.
- Delivered fire prevention material to our local schools during the first week of October so the teachers could go over this material prior to our visit during the week of October 9 to 13.
- Attended the monthly meeting at Station 3 with Chief Hamming and F. F. Matt DeWitt.
- Stopped by a local dental office, after receiving a citizen complaint of candles being lit in the patient waiting area. I advised them that candles must not be a public area where little ones could come in contact with them. They are ok in their private office area but must be protected by a glass globe so no one could come in contact with the open flame.
- Stopped by the Meijer and Target Stores and received donations of smoke detectors and CO detectors for our free drawing at our fire prevention week open house.
- Visited our local schools during the week of October 9 – 13, National Fire Prevention Week.
- Worked with Dave Fontaine, Records Technician at Central Dispatch, on street intersections bordering Georgetown Twp. and Hudsonville City.
- Met with Captain McIntyre and John Turner, HME sales representative, at the HME factory to go over the proper operation of the new SCBA brackets being installed in new E-821.
- Called the Smoke Detector and CO Detector drawing winners and deliver these items to them.
- Gave a tour to a local Day Care group at Station 3. Talked to the little ones about fire safety and showed them the fire trucks.
- Received a complaint from a citizen that the remains of the house that was burnt down Tuesday night the 17th was still smoking. Chief Hamming and I went there and put more water on the hot spots.
- Worked on updating the Campus View Townhouse complex map for our Resource and Address books.
- Gave a fire safety talk and tour to a group of home school students and their parents. This was done at Station 3.
- Went to HME factory with Chief Hamming, Captain McIntyre and new Engine 821's truck committee members to perform a final inspection of the new engine prior to them delivering it to us.
- Worked on updating map book page #8 by adding in a new street that is going in at this time.

- Checked out the correct addresses for the two duplexes on the corner of Voss Street and Walnut Ave. Central dispatch received a call the night before and there was confusion about the street addressing. Come to find out is that half of the duplex has a Vos Street address and the other half has a Walnut Avenue address.
- Worked with Dave Fontaine from Central Dispatch on clearing up the run cards for all the intersections that are on the Hudsonville City and Georgetown Township line. This took a good week to work through and once we had it done Chief Hamming and Chief Mohr looked it over and with a couple of minor changes they gave their ok.
- Updated our map book by adding in new streets and had Jill update our street index for the map book. Made copies and delivered these updates to the three stations.
- On the 25th and 26th Matty and I gave a fire safety talk and a station tour to four classes of preschoolers and their parents from the Georgetown Christian Preschool.
- Assisted Bill Aman, Wyoming Fire Departments Fire Inspector, who had code requirement questions on Automatic Sprinkler Systems, “Sprinkler Head Obstructions”.
- Assisted Bill Aman, Wyoming Fire Departments Fire Inspector, with questions on what is required by the codes on fire protection for chicken rotisserie.
- Received and filed fire inspection reports from Fire Pros Inc.
- Continued working through the codes on what is and isn’t required for public assembly facilities, specifically “Places Of Worship”. This has to do with fire alarm and suppression systems, fire department access to these facilities, ease of exiting the facility for the occupants, use of church buildings for activities other than worship services, etc.

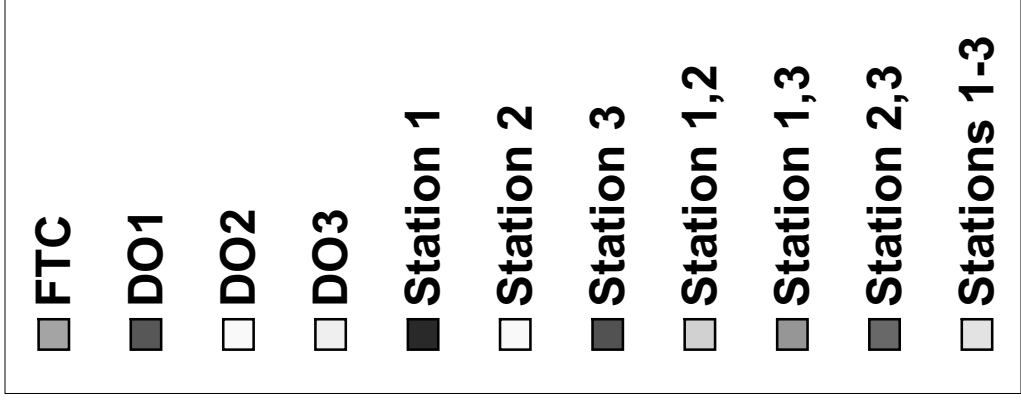
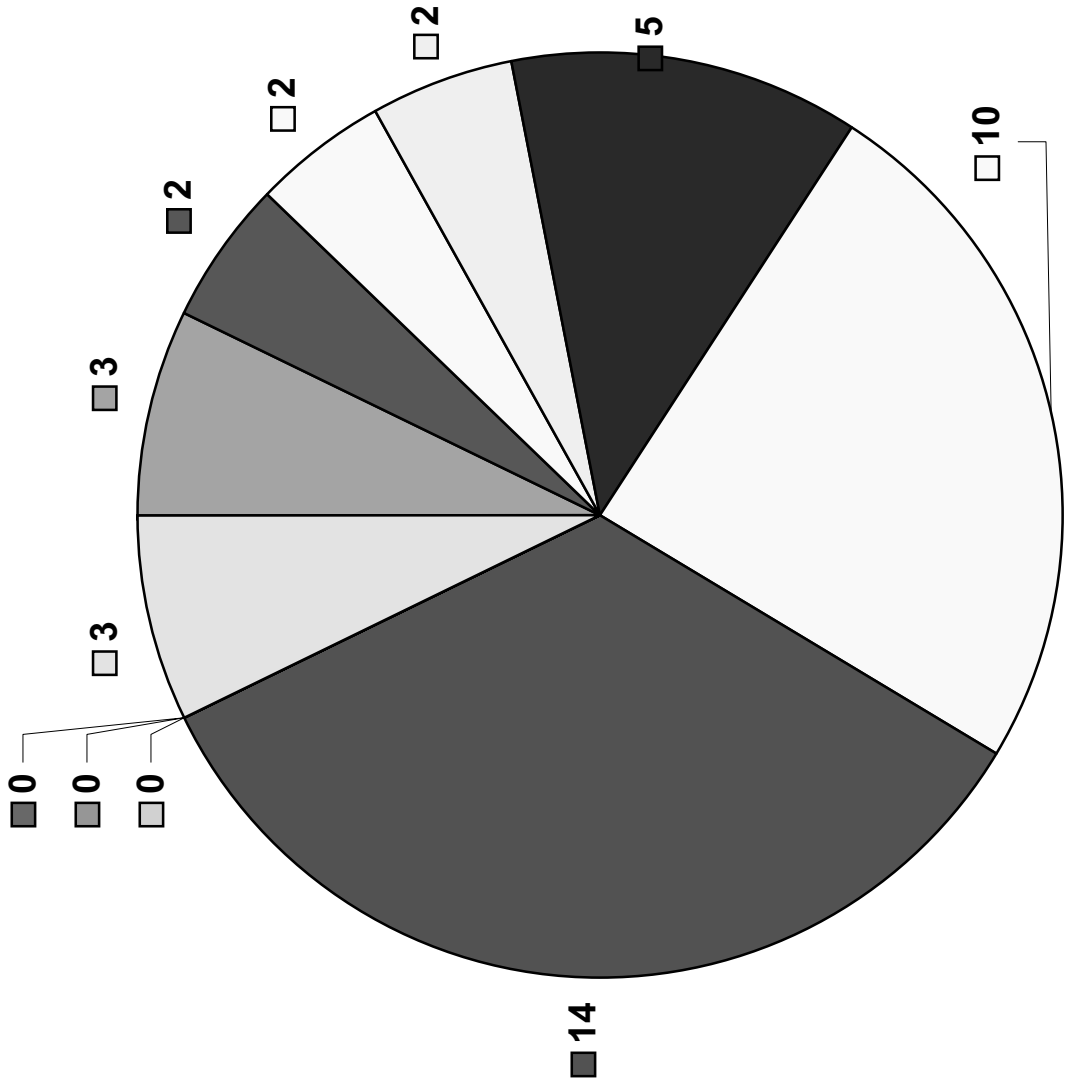
- 2nd** - The Fire Prevention Committee held it's last meeting prior to this years Fire Prevention Week activities. Al went over the schedule for visiting the schools and those who have accepted the invitation to attend our open house.
- 2nd** - We had three cadets and their counselor from Ridgewood CRC come to Station 2 this evening to work on their Fire Safety Merit Badge. F. F. Brett Wright was there to help them out with this. The cadets had their workbook with them and had to ask Brett questions. After this was done Brett took them out to the apparatus bay and showed them the trucks and all the equipment that fire fighters have to use to do their job.
- 5th** - Today F. F. Rob Holland put on a special fire safety talk for the two special needs classes at Georgetown Elementary. There were 42 students in all that Rob talked to.
- 9th to 13th** - This was National Fire Prevention Week. During this week we had two crews going out to our local day care, preschools and elementary schools.
We talked to the students about fire safety and showed the children what a fire fighter looks like when they are dressed up and ready to go into a structure to fight a fire. After the classroom talk the children are taken outside and the fire fighters show them all the equipment on the fire truck that fire fighters use to perform their job. This year we talked to 1,962 students.
- 10th** - This evening Pizza Hut at 6450 - 28th Ave. held their own fire prevention week event. Fire Fighters Dave Butler, Justin Stadt and Nate Streelman took Truck 841 to this event where they talked to local patrons about fire safety and showed them the fire truck.

- 11th** – This evening Fire Fighter Barry Lambers took his Cadet cadre to Station 3 and gave them a tour of the station. Showed them all the equipment that fire fighters use to perform the job and talked to them about being fire safe at home and outdoors while they are camping. There were 4 cadets and 2 counselors.
- 18th** - This morning Deputy Chief Poolman, F. F. Matt DeWitt and I talked to a group of 5 children from a local daycare center at Station 3 about fire safety. We showed them how to stay low in their room when the smoke alarm sounds and crawl over to the window where the fire fighters will come to rescue them. We also showed them how to “Stop – Drop – And Roll” if their clothes happen to catch on fire. We talked to them about not playing with fire and that matches and lighters are “Tools” for adults and that they are not “Toys”. We then took them out to the apparatus bay and showed them the fire trucks.
- 19th** - This morning F. F. Matt DeWitt and I had a group of home schooled children come to Station 3. We had 31 students with their parents attend this fire safety presentation. Besides talking to them about fire safety we had the older students demonstrate to the younger ones how to “Stop – Drop – And Roll”. We then took them out to the apparatus bay and showed them the fire trucks and all the equipment that is used to fight fires. Lt. Feenstra then put on his fire fighting gear to show them what a fire fighter looks like when they come into their house looking for them if they happen to become trapped in their bedroom.
- 25th** - This morning F. F. Matt DeWitt and I took Engine 826 over to Georgetown Christian Preschool and talked to a class of 13 - 3 year olds about fire safety and showed them the tools and hoses on the fire engine. The most anticipated part of the presentation was seeing the water come out of the big gun on top of the fire engine.
- 25th** – This afternoon we had a class of 13 – 4 year olds, along with their parents, from Georgetown Christian Preschool come to Station 3 for a class on fire safety and station tour. Besides talking to the children about fire safety I took this opportunity talk to the parents about fire safety during the holiday season that is fast approaching us. I emphasized being very cautious about using “Candles”. I read off the recent statistics on residential fires caused by candle fires and told them that “if” they were going to be using candles to be very careful.
- 26th** - Today F. F. DeWitt and I talked to 31 – 4 year olds and their parents from Georgetown Christian Preschool about fire safety. I again was able to talk to the parents about the use of candles during the upcoming holiday season.
